Please transfer your \$1,000 holding deposit into our trust account - click link below for account details. Please include your surname and Lot number as a reference when transferring your holding deposit.

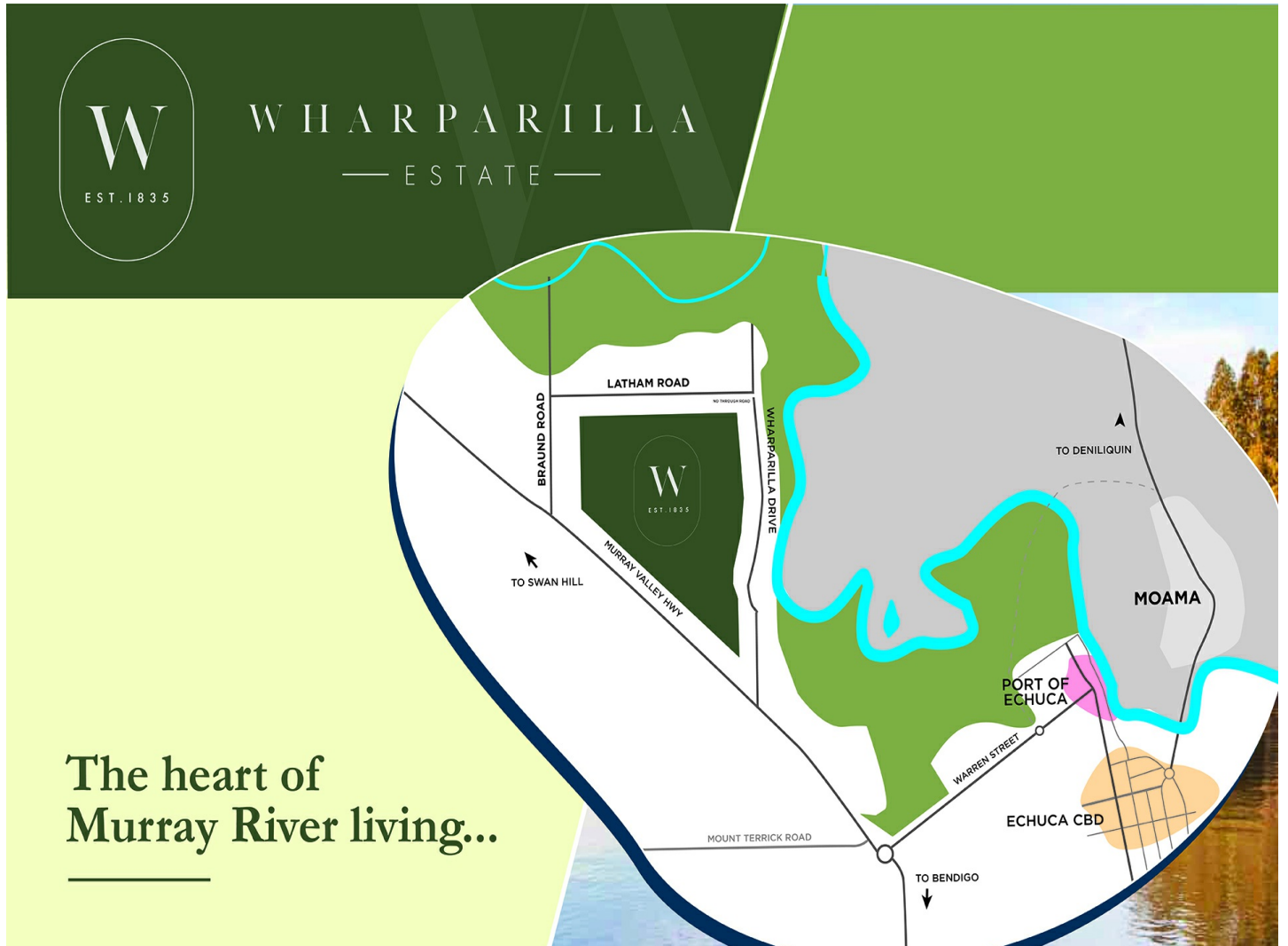
CONTRACT OF SALE & 10% DEPOSIT

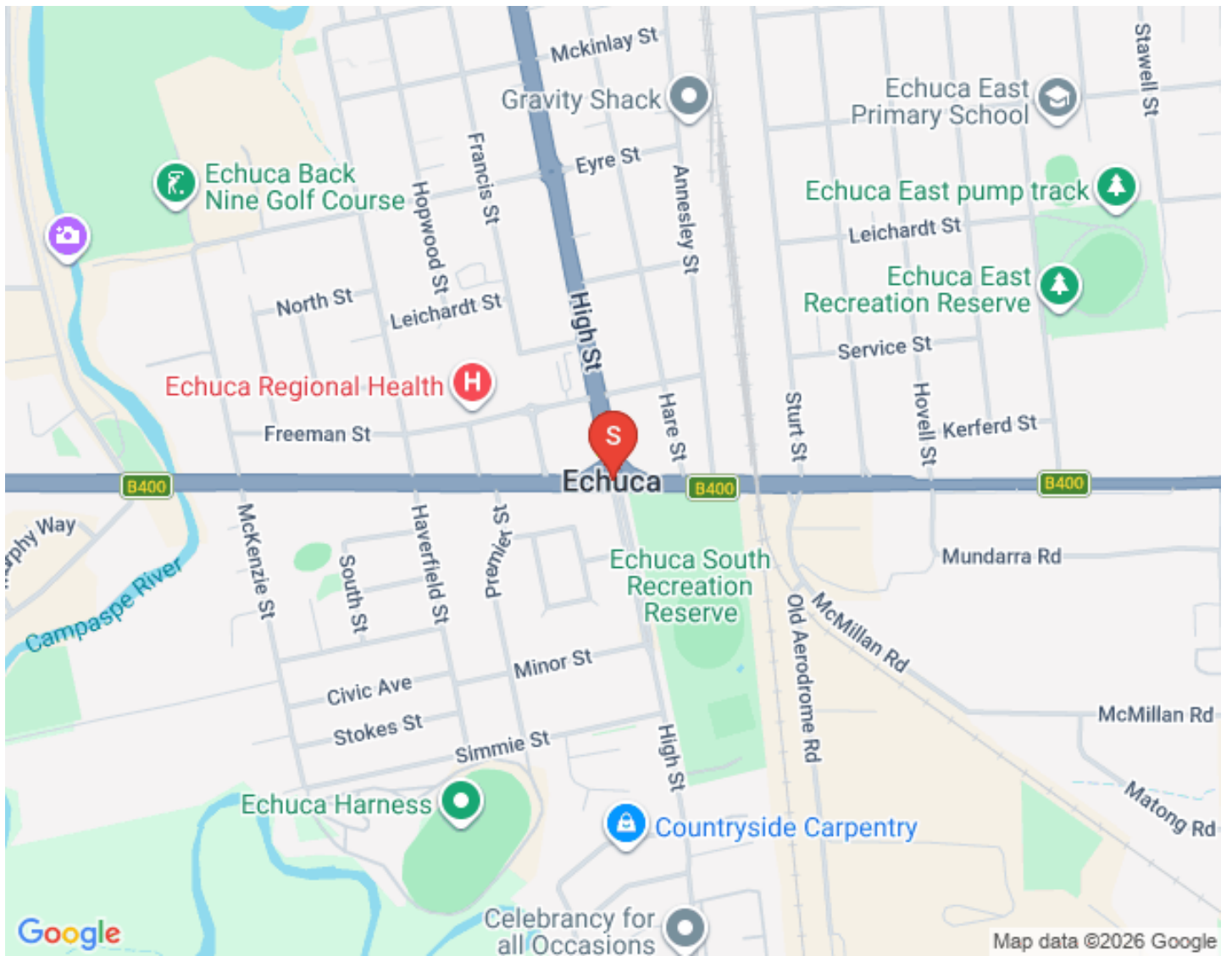
